5.0 **Houston Solar Farm** 5.1 GG provided a presentation to members present on the proposals for a solar farm and battery energy storage facility north of the B790 Houston Road and south of the B790 Houston Road adjacent to Moss Road and Auchans Road. Presentation attached to the minutes; key points raised were: 5.2 Elgin Energy EsCo Limited (Elgin) was established in 2009 and has projects in the UK, Ireland and Australia. 5.3 The proposed development will have a designated project team and will manage a community development fund. 5.4 Existing Hedgerows and trees will be retained 5.5 Equipment height on most of the development will be up to 3.2m at the highest points and the larger battery storage facility will be sited off the Moss Road and screened by trees. 5.6 A management programme will be put in place for hedges, trees, and other plant growth. 5.7 Pre-Application Consultation is not mandatory for Solar Farms, but Elgin carry one out in every case. 5.8 Feedback received by Elgin has been generally positive, but panels have been removed from the proposal in three fields in response to objections from nearby properties and one other property has objected but refused to engage when approached by Elgin. 5.9 Elgin continue to review the positioning of panels, and some may be pulled back due to the topology and their visibility. One section adjoining Houston wood which seems disconnected from the rest of the development area will be removed. 5.10 KM raised the issue of the designated core path running through the site and GG agreed to review the placement of panels in consultation with the community together with what hedging/screening would be appropriate. He was aware of the Bee Happy Group and would anticipate working with them should an application be approved.

5.11	IA raised the matter of unused ground within the project area, it will be under the control of Elgin and can be used to encourage biodiversity.		
5.12	JMc raised the issue of screening on the road side of the development to mitigate the visual impact and all agreed this is likely to be the biggest concern for the community. IA suggested it would be useful if there was some form of visual representation of how the actual site would look. GG stated that the application will include "mode" photo's of various views at year 1 and year 15. IA asked that HCC be kept apprised of ongoing survey reports produced for Elgin to fully inform their position.		
5.13	TH raised the issue of background noise or visual glare from the site. GG assured that the panels make no noise and are matt coloured as they must absorb rather than reflect the light so no glare. There can be a very low hum from the invertors as they switch on, but they will be sited so that this will not be an issue.		
5.14	On the matter of community benefit, GG stated there will be a Community Benefit Fund in the region of £2,000 to £3,000 per megawatt for the proposed 50 megawatt site. GG will provide a draft agreement to HCC for consideration.	GG	
5.15	GG will provide a soft copy of the presentation that HCC can share.	GG	
5.16	Elgin's planned timescale for the development is: Application Submitted – January 2023 Estimated 1 year to go through all approvals Go Live 2025		
5.17	Elgin will publish again when the planning application is submitted at which time residents will be able to comment on the application.		
5.18	IA thanked GG for his presentation and GG left the meeting.		
5.19	After the Elgin representative GG had left the meeting, IA reported on the response to HCC's post on Facebook asking for comment regarding the proposed development. While a few members of the community had commented both for and against, there was no clear		

	indication of public feeling at this time. It was agreed that, in the absence of a "clear steer" from the community, HCC should not take an active part at this time but should continue to share information received with the community and monitor public response.	IA
