11.1	Bunting – Looking at purchasing bunting for Houston and Crosslee. Quote covers village: 850m of bunding and 25 flags. £3,500 quote excluding VAT. This includes costs of prizes for coronation champions. The company has agreed to meet on 25 th of April to cover which columns to place the bunting. Bunting to be installed on 29 th , 30 th April and be taken down on 11 th , 12 th May. It was agreed, after a debate and vote, that the bunting would be purchased from a charity, if possible, with attempts to get a discount made. 11.3	Tree – McLaren's offering 2 types of common oak: One single stem 8ft at £30, others older and taller with more stems at £75, budget of £100 including stakes and ties. The favoured position for the tree is below the orchard coming off of roundabout. Bee Happy would plant for donation. Looking at £160 each for plaques from purchased charities and veterans. This does not have to be agreed upon just now. HCC/km will reach out to churches and suggest a joint procession to planting of tree.
